Payment Options for Membership Renewal

1) Military Allotment ~

~ **ACTIVE DUTY PERSONNEL** - Set up a monthly allotment by (a) going to <https://CG.direct-access.US> from a CG workstation or <https://HR.direct-access.US> from outside, click on the "Self Service" option and follow prompts to "Allotments" or by (b) completing an Allotment Worksheet CG PSC-2040 (Allotment Worksheet) and sending it to your Servicing Personnel Office for input. Please note: the minimum monthly allotment is \$6.00 and the Fund Code is 014. Please call or email Karen Licitra at the Alumni Association (860) 442-2683 x 11 or klicitra@cgaalumni.org to specify how you want payments above dues credited, as the Personnel Service Center (PSC) will only transfer the deduction to us. You may also choose to use the other forms of payment listed below.

~ **RETIREES** - Retired personnel can start or change an allotment by (a) calling the Personnel Service Center (PSC) on the toll-free line in Topeka, Kansas at (800) 772-8724 and ask the retired pay representative to input the change for you, or (b) sending a letter request to Personnel Service Center (RAS), 444 S.E. Quincy Street, Topeka, KS 66683-3591 or (c) filling out Form CG PSC-2040 and sending it to PSC (RAS) –this form is available on-line at <http://www.uscg.mil/hq/psc/forms>. Please note that the minimum monthly allotment is \$6.00 and the Fund Code is 014. Please call or email Karen Licitra at the Alumni Association (860) 442-2683 x 11 or klicitra@cgaalumni.org to specify how you want payments above dues credited, as the PSC will only transfer the deduction to us. You may also choose the other forms of payment listed below.

2) Credit Card - Annual credit card payments are processed in the Alumni Association office with information obtained from the other side of this form. You may call (860) 442-2683 x 11 and provide the information to us over the phone, fax the completed form to (860) 442-2690 or mail it to: USCGA Alumni Association, 47 Mohegan Ave, New London, CT 06320-8111.
