that, she was Executive Director of The Reporters Committee for Freedom of the Press in Arlington, Virginia, for 14 years. She was appointed Director of The Silha Center for the Study of Media Ethics and Law in May 2000, and was named to the affiliated faculty of the University of Minnesota Law School in March 2001. During the Spring 2004 semester, she was a Distinguished Visiting Professor of Law at Suffolk University Law School in Boston, Massachusetts.

Prof. Kirtley speaks frequently on First Amendment, freedom of information and media ethics issues, both in the United States and abroad, including Argentina, Belarus, Brazil, Bulgaria, Chile, China, the Czech Republic, the Dominican Republic, Estonia, Hong Kong, Jamaica, Japan, Latvia, Mongolia, Nepal, Philippines, Poland, Russia and Turkey, as well as in the United Kingdom, Ireland and Canada. She is a commentator for *Nieman Watchdog*, and wrote the "First Amendment Watch" column for *American Journalism Review* from 1995-2006.

Prof. Kirtley received her J.D. degree from Vanderbilt University Law School in 1979. She holds bachelor's and master's of journalism degrees from Northwestern University's Medill School of Journalism.

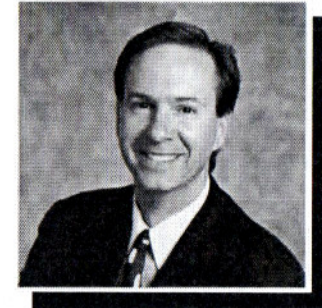
Before joining the Reporters Committee staff, Prof. Kirtley was an attorney for five years with the law firm of Nixon, Hargrave, Devans and Doyle in Rochester, N.Y. and Washington, D.C. She is a member of the New York, District of Columbia, and Virginia bars. Prof. Kirtley also worked as a reporter for the *Evansville (Indiana) Press* and *The Oak Ridger* and *Nashville Banner* (Tennessee).

Prof. Kirtley serves on the board of directors for the Sigma Delta Chi Foundation and the editorial board of *Communication Law and Policy*. She has received many awards and honors, including the Edith Wortman First Amendment Matrix Foundation Award in 2004; induction into the Medill School of Journalism's Hall of Achievement in 1999; the FOI Hall of Fame in 1996; and the John Peter Zenger Award for Freedom of the Press and the People's Right to Know from the

Paul H. Layne
Executive Vice President
Brookfield Properties



Paul Layne serves as Executive Vice President for Brookfield Properties, responsible for holdings in Houston and Southern California, with 8.3 million square feet in Houston and 6 million square feet in Southern California. He is responsible for all aspects of the region's activities, including leasing, operations, property management, legal, accounting, development and construction.

Mr. Layne joined Brookfield Properties predecessor, Trizec Properties, in May 1994 as a Vice President responsible for activities in Houston, Texas. In 1995, his responsibilities were expanded to include the entire Southwest Region, which included Houston, Dallas, Tulsa and Los Angeles and averaged approximately 17 million square feet. He was active in the property acquisition and due diligence process for the purchase of over 20 million square feet in markets spreading across the United States, including the Sears Tower in Chicago.

Prior to joining Trizec, Mr. Layne was Senior Vice President for the Horne Company for nine years and Vice President and General Partner for Prime Asset Management, Inc. for five years, responsible for the 75-story Chase Tower in Houston.

Mr. Layne received a bachelor's degree in management from the University of Houston and attended South Texas College of Law. Mr. Layne serves on the boards of the Houston Downtown Management District, the Central Houston Association, the University of St. Thomas; Houston's Coalition for the Homeless and serves on the finance council and school board of St. Vincent de Paul School and Church, as well as overseeing the long range planning committee. Dr. Louthan, Senior Consulting Scientist, Emeritus at the Savannah River National Laboratory, is a Fellow - ASM International, a member of the Board of Trustees of the National Youth Science Foundation, Editor of the *Journal of Failure Analysis and Prevention* and a frequent lecturer to youth organizations, high schools, colleges, universities and professional societies. Mac has served as member of the Board of Directors and as President of the International Metallographic Society, editor of *Microstructural Science*, chairman of ten international conferences, editor of eight technical proceedings and author of approximately 200 peer reviewed papers.

He also served a Chairman of the Nuclear Weapons Complex Network of Senior Scientists and Engineers, on the Editorial Review Board of *Material Characterization*, as Key Reader for *Metallurgical Transactions* and as a reviewer for the *Journal of Nuclear Materials* and *Corrosion*.

His awards include the Henry Clifton Sorby Award for outstanding contributions to the field of metallography, the Citizens for Nuclear Technology Awareness Award as Outstanding Scientist in 2000, the Allan Ray Putnam Award from ASM International, the Presidents award from IMS and was elected as an Instructor of Merit and Outstanding Educator by the Materials Engineering Institute. As Professor of Metallurgical Engineering at Virginia Tech, he was elected to the Academy of Teaching Excellence, received numerous certificates for teaching excellence and the Wine (peer

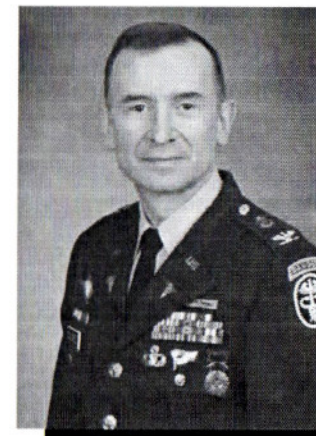

COL Moores has held a wide variety of assignments and staff positions as a Medical Corps Officer and an Infantry Officer. Some of his more noteworthy assignments include: Rifle Platoon Leader, C Co, 325 Parachute Infantry Regiment, 82d Airborne Division, Fort Bragg, NC (1985); Neurosurgeon, Forward Surgical Team, Bagram, Afghanistan (2002); Commander, 4th Medical Team (Neuro), Combined Forces Land Component Command (CFLCC), Iraq (2003); Chief of Neurosurgery, Walter Reed Army Medical Center; Chief of Surgery, Walter Reed Army Medical Center; and his current position as the Deputy Commander for Integration, National Naval Medical Center.

COL Moores is a graduate of the Command and General Staff College, AMEDD Officer Advanced Course, and the Army's Infantry Officer Basic Course (Honor Graduate).

COL Moores' military awards, decorations and honors include: the Defense Meritorious Service Medal (DMSM), the Army Meritorious Service Medal (MSM) with oak leaf cluster, the Joint Service Commendation Medal, the Army Commendation Medal (1 OLC), the Joint Service Achievement Medal, the Army Achievement Medal (2 OLC), Ranger Tab, Expert Infantryman's Badge, Master Parachutist Badge, Pathfinder Badge, and Jungle Warfare Badge. Captain Rick Muldoon currently serves as the Program Manager, H-53 Heavy Lift Helicopters (PMA-261).

A graduate from the United States Naval Academy and the Naval Post Graduate School, Captain Muldoon earned a Bachelor of Science degree in Applied Science and a Masters of Science Degree in Systems Engineering and Integration. He began his acquisition career at the Empire Test Pilot School UK in 1992, spent 3 years conducting H-53 flight test and has led engineering and acquisition teams in the H-53, and E-6B program offices. He also served as the Deputy for Operations, Program Executive Office Air ASW, Assault and Special Mission Programs (PEO(A)). As an unrestricted naval aviator, Captain Muldoon has logged flight time in more than 41 unique aircraft including 50 hours of combat mine countermeasures, in the MH-53E, during Operation Desert Storm. Capt Rubel, son of Rear Admiral and Mrs. David Rubel, Graduated from the Naval Academy in 1972. He served on Guided Missile Destroyers as Gunnery Officer, Fire Control Officer, and Damage Control Assistant, Weapons and Operations Officer. He took part in Operations in the

After retiring from the Navy, he was appointed to his current position as the "Distinguished Military Professor of Ethics" at the Naval Academy. In this capacity, he teaches the Core Ethics Course, serves as the director of the Core Ethics Program, and is involved with the Character Development Program. He has published cases in the International "Journal of Military Ethics". Capt Rubel co-edited and co-authored "*Case Studies in Military Ethics*" (Person Publishing, 2004) and has written cases for "*The Journal of Military Ethics*".

He is currently on the Maryland State Board for Character Education. He is leading a team that will travel around the world to conduct Ethics and Character training for 800 Navy Chaplains.

Professor Douglas V. Smith

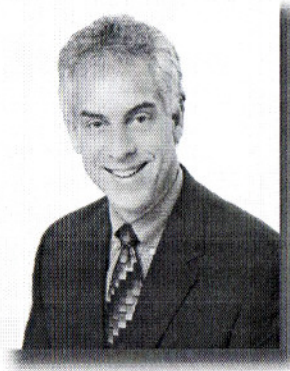
